

No Canyon Hills

"In 2005, a proposal for a 200+ luxury gated housing development called 'Canyon Hills' was approved by LA City Council, based on an Environmental Impact Report conducted in 2003. Even back then, the project was controversial for its sweeping destruction of the Verdugo Mountains in Tujunga."

"Now, almost 20 years later, the developer (Whitebird Inc.) wants to begin construction before the land-use agreement expires. Last month, residents learned that Whitebird Inc. had recently pulled a Grading Permit to begin gutting the mountain. This process entails grading the scenic hillsides, cutting some ridge-lines down 80 feet, paving over ecologically important mountain streams and ripping out hundreds of Coast Live Oak trees. The permit could be approved any day now."



"But the botanists are mobilizing. A small but mighty group of plant and wildlife advocates have joined forces online and launched a campaign to protect this important wildland habitat. In less than two weeks, a petition to oppose the development has garnered more than 5000 signatures —and counting. Local residents have found the campaign and signed on to help. We are gaining momentum, and we plan to grow this effort all the way to the top."

Note from Gerry Hans, Friends of Griffith Park:

The Revised Final EIR for the Los Angeles Zoo Vision Plan is available for public review!

The City of Los Angeles (City) has prepared the Revised Final Environmental Impact Report (EIR) for the proposed Los Angeles Zoo Vision Plan (proposed Project), consistent with the California Environmental Quality Act (CEQA). Focused sections of the Final EIR have been revised to incorporate Alternative 1.5 and address comments received in response to the Focused Recirculated EIR. The Focused Recirculated EIR was circulated during a 71-day public review period from **July 14**, 2022 to **September 23**, 2022, and virtual public meetings were held on **August 15**, 2022 and **September 12**, 2022. The City's responses to these comments can be found in Chapter 9.0 of the Revised Final EIR. The Revised Final EIR can be downloaded from the Department of Public Works Bureau of Engineering's (BOE) website: https://eng.lacity.org/about-us/divisions/environmental-management/projects/los-angeles-zoo-vision-plan.

The City Council's Neighborhoods and Community Enrichment Committee will consider the certification of the Revised Final EIR at a special meeting on **June 28, 2023**.
