Sierra Sage General Meeting WITH Guest Speaker, Dr. Kathleen Treseder

s an evolutionary biologist and a professor at UC Irvine, Dr. Kathleen Treseder is a force to be reckoned with. In 2017 she was so concerned with

the climate crisis that she decided research and teaching were not enough.

Dr. Treseder co-founded Orange County CleanPower, a grassroots organization of over 30 non-profits, businesses, school organizations, and faith groups. With her leadership they successfully lobbied five cities in Orange County to form Orange County Power Authority—https://www. ocpower.org/.

OC Power allows cities that have currently been buying energy only from Southern California Edison to choose their source of power. The cities in turn give businesses and residential customers the ability to buy power from clean energy sources.

Dr. Treseder will be there in person and address the formation of OC Clean Power, including the ins and outs of Energy Choice for cities. How are the energy choice plans paid for? Is it the same or less expensive than power from only fossil fuel-based power companies? What choices does it allow residential customers? Is having a choice of energy less harmful to the environment?

Note: this will be a hybrid presentation as is open both in-person and on Zoom. Dr. Treseder will be there in-person, and the Q&A following her presentation may be limited to the live audience. Local Happenings

San Clemente Beach Walk Wednesday, July 13, 2022

Wednesday, July 13, 2022 | Arrive 8:45 am, Walk 9:00 am

Our 7.5 mile out and back route has short hills on each end just to provide a little exercise. Both hills combined are a bit

under 800 ft of gain, so this is a pretty easy outing. For those not up to the full distance, the free San Clemente Trolley can get you back to your car from the San Clemente pier and reduce the distance by about 2 miles.

Our route takes us over relatively new trails in the Sea Summit area with views of the ocean and maybe some small wildlife before we drop down to the beach. In the middle of



to the beach. In the middle of **San Clemente Beach Walk** the week the beach crowds should not be too bad.

We have a snack/rest break in the middle of the hike at San Clemente State Beach Park. There's another rest stop near a small museum with historic memorabilia relating to surfing, which may be of interest. There are many restrooms along the way including at the beginning and end of our walk.

We should be back at the Outlets around lunch time. There are several nearby restaurants, if people wish to eat there.

- Bring: Sun protection is highly recommended as is water, a snack, sun hat, and comfortable walking shoes. Almost all the way is wide and smooth, so hiking poles should not be needed.
- Additional Directions: So we can start walking at 9:00 am, meet by 8:45 at the Outlets at San Clemente just north of Blaze Pizza (225 West Avenida Vista Hermosa, San Clemente). From southbound I-5, exit at Avenida Vista Hermosa and turn right. Go past the first entry to Outlets, past Avenida Costa Azul, over a bridge then turn left into Outlets. Make the first left in the parking area, then left again.

Update: Orange County Power Authority

"Better a diamond with a flaw than a pebble without" or trouble at OCPA delays efforts to reduce GHG output.

The Mission Viejo city council invited **Brian Probolsky**, the problematic CEO of the Orange County Power Authority to

make a presentation on June 28. This was what I had asked for months ago, and I am grateful to councilwoman **Trish Kelley** for putting him on the agenda. As the subject of Community Choice Energy had been raised in 2021, and subsequently put aside for future discussion, this would have been a fine opportunity for the city council to vote for the adoption of CCE for Mission Viejo.

Alas, this wasn't to be so because long-simmering doubts of Probolsky's leadership as well as OCPA's transparency and rates have come to a boil during the last few weeks, throwing a monkey wrench into our efforts to convince the first south county city to vote for greener electricity. For me, this is a classic instance of the perfect becoming the enemy of the good and of process becoming more important than results.

I'd like to know why it is necessary to examine the OCPA's dirty linen in public? Why was this not done behind closed doors? And who hired Probolsky in the first place since he is such a bad egg?

Climate change appears to be accelerating, and delaying GHG output reductions will have disastrous consequences for us and future generations. We need to act fast across the board, and if we cannot even pick the low hanging fruit if it's not quite to our taste, such as the currently constituted OCPA, we're doomed. Besides, the usual suspects that want the CCE movement to fail are having a field day over this brouhaha, and it keeps me, for the time being, from advocating effectively for OCPA before the MV and any other city council.

Instead, the MV city council will postpone any action on CCE/ OCPA, and I'll ask Climate Change and Global Warming to kindly take a time-out until the OCPA board figures out how to improve its act. This unfortunately, is not an entirely unexpected outcome since discussing and postponing Climate Change actions have been the *modus operandi* of governments and businesses around the world for half a century. If future generations can look back at our behavior, they'll probably call us the "worst generation".
