NOVEMBER BALLOT MEASURES:

Measure: Proposition 1 - Affordable Housing Bond

Sierra Club CA Recommends: SUPPORT (PASSED)

Summary: The bond would authorize \$4 billion to fund low-income housing developments and subsidize home loans for veterans.

The measure provides an important opportunity to address California's extreme housing crisis. Sierra Club supported SB3, the legislation that place this bond on the ballot.

Measure: Proposition 3 - Water Supply and Water Quality Act of 2018

Sierra Club CA Recommends: OPPOSE (DID NOT PASS)

Summary: NoProp3CA.com. The bond would provide \$8.877 billion for various water projects and programs.

Prop 3 would cost California's General Fund \$430 million a year for the next 40 years. This is more than half the amount California spent on fighting fires in 2017. Prop 3 will take money out of the General Fund that is critically needed for other purposes.

We just passed a \$4 billion water bond in June and haven't even begun to spend the money. Do we need to put another almost \$9 billion on the state credit card?

It's a pay-to-play bill. The big payers get the biggest handouts. Prop 3 spending would not have to go through Legislative oversight, so the public can't oversee how funds are spent or if the programs are effective.

Measure: Proposition 6 - Eliminates Recently Enacted Road Repair and Transportation Funding

Sierra Club CA Recommends: OPPOSE (DID NOT PASS)

Summary: The measure is an attempt to repeal Senate Bill 1, the Road Repair and Accountability Act, passed in 2017 that raises about \$5.2 billion a year to fix the state's crumbling roads and bridges and improve public transit service.

Measure: Proposition 10 - Rent Control

Sierra Club CA Recommends: SUPPORT (DID NOT PASS)

Summary: The proposition aims to repeal the Costa-Hawkins Rental Housing Act.

Local governments are restricted from implementing affordable housing measures to reduce displacement and rent gouging. Repealing this law would increase housing stability, particularly for the most vulnerable, low-income households.

Measure: Proposition 12 - Farm Animal Confinement

Sierra Club CA Recommends: SUPPORT (PASSED)

Summary: Prop 12 would prevent animal cruelty by phasing out extreme methods of farm animal confinement.

The initiative builds on Prop 2 (2008), which restricts farms from confining pigs, calves and hens in cages.

Prop 12 includes specific size restrictions for cages and bans non-compliant meat and eggs from being sold in California.
